



Victorian Veterans Council Biographies

Peter Haddad, Chair

Peter served as an Army Officer for 38 years, including active service in Vietnam, and retired in 2005 at the rank of Major General. For the period 2000-2005, he was the senior defence officer in Victoria and represented the interests of the Australian Defence Force in this state. As a logistician, most of Peter's career at senior levels was spent in joint appointments where he had responsibility for supporting Army, Navy and Air Force units. Peter has a strong interest in veteran's issues but is not affiliated with any Ex Service Organisation.

Peter is the Principal of a consultancy company and currently has responsibility for the operations of the Defence Industry Unit established by the Victorian Government to assist with the sustainment and development of Victorian firms in the defence industry sector. He is also an Adjunct Professor in the School of Management at RMIT University.

George Logan, Deputy Chair

Enlisting in the army in 1956, George served for nearly 36 years with war service in Malaya, Malay-Thai Border and Vietnam.

Currently a member of the RSL State Executive, George is a former Board Member of Melbourne Legacy, was President of the Beaumaris RSL, The Royal Australian Regiment Association, The Australian Army Training Team Vietnam and the Defence Reserves Re-employment Board whilst acting Chair of the Patriotic Funds Council.

Since retiring, George has been involved in volunteer work with several organizations, including Board membership of Vasey RSL Care Ltd.

Peter Colliver

Peter served in the RAAF Reserve for 8 years and for 16 years with the Air Training Corps (now Australian Air Force Cadets), during which he commanded the Victorian Squadron for five and a half years.

A member of the Royal Australian Air Force Association (Victorian Division) since 1968, Peter has served a total of eleven years as a member of the Divisional Council and six years as Treasurer before being elected State President in May 2004. Peter was elected as a National Vice President in March 2006.

In a career spanning almost 50 years Peter has occupied senior roles in accounting and finance, employer advocacy and association management. For the past 14 years he has been a principal of a public accountancy practice. He is a Fellow and accredited quality assurance reviewer of CPA Australia, a licensed financial advisor, a registered tax agent and has completed training as a Pension Officer.

John Deighton

Graduating from Portsea Officer Cadet School, John spent 30 years as an Army Officer, including active service in Malaya, Borneo and Vietnam. In 1983 he resigned from the Army with the rank of Brigadier.

John was the CEO of the RSL (Victorian Branch) for 17 years before retiring in April 2006. He was a member of the Patriotic Funds Council of Victoria for four years and is now the RSL representative on the Council.

Bob Elworthy

Bob has been a member of the Vietnam Veterans Association of Australia (Victorian Branch) since 1997 and President since 2005. Bob enlisted in the Australian Army in 1967. He served in Australia, South Vietnam, Singapore and Hong Kong and retired as a Major in 1987.

He worked as a Commonwealth Public Servant from 1987 to 2000 in the Defence Signals Directorate and the Royal Australian Air Force Logistics Command. Since 2000, Bob has devoted his time to working with ex-service organisations.

David Ford

David was an Army Officer for 20 years and served in Vietnam. He was then employed as Chief of Protocol for the Victorian State Government until he semi retired in 2000. David is an active Legatee, a former President of Melbourne Legacy and represents Legacy on the Veterans Council. He is also a Life Governor of the Shrine of Remembrance.

Mary Kelly

Mary enlisted in the Army in 1980 and served in the Royal Australian Corps of Signals for 16 years. Mary is a veteran of Cambodia where she served in the Force Communications Unit with the United Nations. Mary was in Cambodia for 13 months and worked in Sihanoukville and Phnom Penh. Mary is currently employed with the Defence Computing Bureau in the Information Technology area. Mary had been a member of the Patriotic Funds Council of Victoria for 3 years.

John Lord

John served with the Royal Australian Navy for over 36 years. He served in Vietnam, commanded two major warships and directed naval operations for East Timor during 1999-2000. John was also Commander of Northern Command in Darwin.

Retiring from the Navy with rank of Rear Admiral, John was appointed Chief Executive and Director of the Marine Board of Victoria and a member of Australian Maritime Group and the National Plan Committee for maritime emergency responses. From 2003-07, he was Executive Director of P&O Maritime Services responsible for international and Government business. He is presently Chairman of Defence Maritime Services Pty Ltd and a director of Huntingdale Golf Club.

Stephen Ryan
